LIZZ CAMPOS

Elizabeth Campos, a 25 year veteran of the Alameda County Public Defender Office, has done it all: two capital cases to verdict, homicide trials, supervisor, and juvenile attorney. Raised in Monterey, daughter of a cannery worker and a farm worker turned musician, she was a telephone operator, mom of two daughters, graduate of the University of California Berkeley, School of Education, who then went on to get a teaching credential there and completed a Masters in Education at Stanford. While in law school at Hastings, she clerked at the Contra Costa County Public Defender Office and both the Municipal and Superior Courts in that county before clerking for then Supreme Court Justice Cruz Reynoso.

Lizz is the true defender daughter of Ruth Young: passionate in her work, compassionate for her clients, fearless in trial, and an inspiration to those who have the privilege to work with her.



KEYNOTE ADDRESS:

The Crisis in California Prisons

California prisons have been extraordinarily overcrowded for many years now, and the resulting crisis is getting worse not better. Professor Haney has been studying the California prison system for some 30 years. He will discuss how and why the current crisis has come about, what it is doing to our clients (during and after their incarceration), and what needs to be done to address these urgent problems.

KEYNOTE SPEAKER:

Professor CRAIG HANEY, J.D., Ph.D

UC Santa Cruz

Craig Haney received his Ph.D. (in psychology) and J.D. degrees from Stanford University in 1978. One of the principal researchers on the highly publicized “Stanford Prison Experiment” in 1971, he has been studying the psychological effects of living and working in actual prison environments since then. His work has taken him to dozens of maximum security prisons across the United States and in several different countries where he has evaluated conditions of confinement and interviewed prisoners about the mental health consequences of incarceration. He also has been studying the backgrounds and social histories of persons accused or convicted of serious violent crime for more than 25 years, and has conducted research on and written extensively about the nature of capital jury decision-making process.

His scholarly writing and empirical research have addressed a wide range of crime and punishment related topics, including the causes of violent crime, the quality of fairness and justice that characterizes our system of capital punishment, psychological mechanisms by which prisoners adjust to incarceration, and the adverse effects of prolonged imprisonment, especially under severe conditions of confinement. His widely praised book, Reforming Punishment: Psychological Limits to the Pains of Imprisonment, was published by American Psychological Association Books in 2006. It focuses on the costs, consequences, and potential reform of the system of imprisonment in the United States.

Haney also has served as a consultant to various governmental agencies, including the White House, Department of Justice, California Legislature, and various state and federal courts. Haney’s research, writing, and testimony have been cited in many judicial opinions that address death penalty law and procedures, as well as the psychological consequences of incarceration.
